

The United States immigration system seems to be going through some major changes. Some US visa guide books describe visas that have now or will become obsolete or encounter changes in their requirements/criteria. This book by Execvisa is not the case. It has included many of the US visas that should survive current/future immigration reform and most of these visas should experience minor changes to their criteria. Because this book includes up-to-date visa/greencard options, it is ideally suited to foreigners planning to work or study or do business or startup in USA. The final two bonus chapters on intellectual property IP cover trademark branding and patenting through the US IP system. It also has great tips on business startup/expansion in USA. The book manages to explain US IP & immigration into simple and interesting terms. The book is not too long either and it is straight to the point. Just by scanning through the criteria pages in the different visa sections, you'll know very early which visa/greencard suits your qualifications/skills/studies/investment. So you can narrow down your visa/greencard options and give more attention to their application/petition process. You'll know then whether to pursue the application/petition by yourself or via the help of a US Visa attorney.

Big emigration/travel agencies usually promote the services that they offer for one or maybe two specific types of USA visas. But this book discusses a lot of other visas that you usually never hear about in the media or marketing promotions. These visas are actually hard to discover on your own. But this book outlines your other options for work/business visas and the green card. It covers all the necessary requirements involved in filing the US application. I really like the last two chapters on Patents and Trademarks. I am really interested in starting a business in the US and these two bonus chapters are a great startup guide. They describe what is involved in protecting your ideas in the US. Every country has different intellectual property rules

I wish I read this book before I went to America. If I knew about the visas in this book, I would never have filed for my current visa. My current visa is too work restrictive but now I am dealing with an emigration lawyer to file a green card application through one of the visas I discovered in this book. The book is great because it explains whether you qualify for some of these little-known visas. The criteria and process is also laid out for you in simple terms. It is not technical and is really very easy to understand.

I learnt a lot from this book. Many of the US visas described in this book are unfamiliar to the wider public. I bought the book because I wanted to learn more about different types of work visas and entrepreneurship visas for the United States. Now I feel more prepared after reading this book and now I know what to expect with emigrating to USA. The book also explains how to get a green card which is great, because I like knowing that the green card is still a back-up option and not something so far out of reach.
