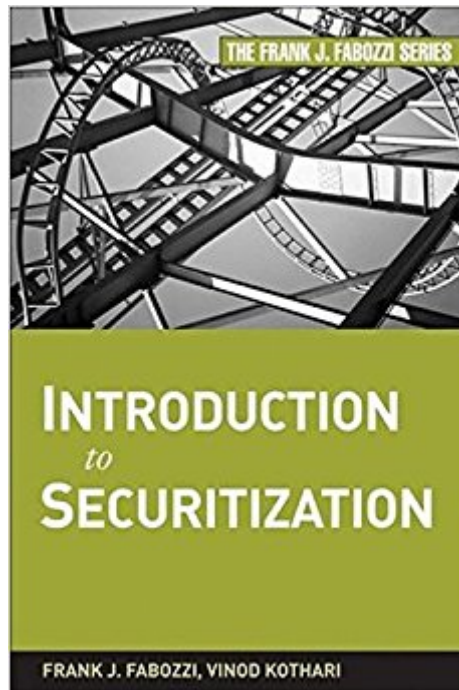

To make a long story short, the authors throw the reader into the deep end of the pool and never look back. I author several empirical financial academic papers each year, and find that establishing the big picture (i.e., the trunk of the tree) at the BEGINNING encourages the reader to continue reading. This book leads the reader to ask WHY, WHO, WHERE, HOW . . . largely because the the authors fail to provide the reader with a general map for the game. Bottom line: this book is a poor introduction to securitization.
