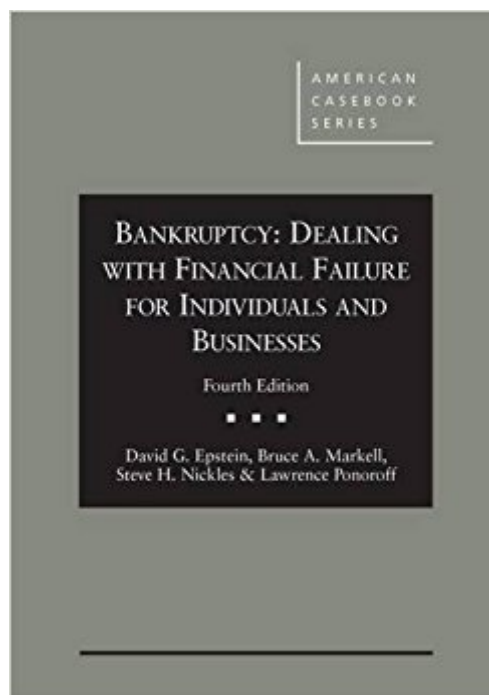

Synopsis

Together, the four co-authors have taught bankruptcy courses at more than 20 very different law schools; one of them sat as a bankruptcy judge for nine years; and all four have substantial practice experience. The book is fun to read and breaks down complicated and difficult concepts into bite size pieces. The authors mix in jokes (even jokes about themselves) to make the "units" entertaining. The other comment complains of practice problems without explanations. That commenter fails to understand that this is a text book meant for law students. The problems are discussed in class with the professor and the professor walks you through the problems. It would be pointless for classroom discussion if the answers are provided, just like it would be pointless for a math book to provide the answers to its problems. The problems are extremely helpful when trying to apply the Code to everyday realities. I strongly recommend this book for a law school class on Bankruptcy.
