

Best simple book/essay on the purpose and misuse of "Law". Every citizen should read this once each year. It should be required reading beginning in elementary school at every grade level.

I read how it was esteemed by others and was also very impressed. It is a different way of looking at the law and give you a whole new appreciation of what the law is for and how easily it can be abused. The basic premise is that the purpose of law is to protect people. Too little law protects inadequately. The much more frequent problem is that too much law ends up hurting the people rather than protecting.

If you're developing your political philosophy, or trying to gain an understanding of rights, I'd highly recommend this book. Many people need to be reminded that the government and their laws don't determine right from wrong, and they also aren't the source of our natural rights.
